New agreement or modification agreement

New agreement:	The agreement does not yet exist. You have never registered it before.

Assignor and assignee

The Assignor is the party handing over the rights, in this case the original publisher.
The Assignee is the party receiving the rights, in this case the sub-publisher.
For one of these two options, fill in your own data. Name, IP Name Number and society are mandatory fields.

Agreement partner

Only to be filled in if you are a sub-publisher.
If applicable, fill in the publisher via whom you claim the original publisher here.
This is the publisher with whom you have concluded an already known sub-publishing agreement.

Type of agreement:

General:	Agreement applies to all works of the original publisher. Agreement applies to a selection of works of the original publisher. Fill in the table LIST OF WORKS TO WHICH THE AGREEMENT APPLIES. Title and right holder(s) are mandatory fields.
Specific:	Does it concern more than six works? Then you can attach a separate list with titles and right holders.
Sales/Manufacturing:	The agreement applies to works on carriers sold or manufactured in the specified territory.

Start date agreement

Here you specify the start date of the agreement. This date may not be more than one week in the future.

Territory

Here you specify to which territory the agreement applies.

Shares of performing rights and mechanical rights

Fill in the shares in % for both types of rights.

For '% Assignor': fill in the share that the original publisher maintains.

For '% Assignee': fill in the share that the sub-publisher maintains.

The sum of '% Assignor' and '% Assignee' may not exceed 50% for the performing rights and 100% for the mechanical rights.

Note: the shares are calculated on the share in the work. If you specify that both the assignee and the assignor are entitled to 25%, fill in 25% in the appropriate boxes. The sum of the specified shares is then 50%. The remaining 50% - that are not filled in on the form - go to the composer(s)/ author(s). If you change the shares of an agreement, all works in which you applied the initial right allocation will be changed. Works with deviating shares will remain unchanged.

Mechanical rights assignee 100%.

If you specify that the Assignee share in the mechanical rights is 100%, then explain here why you are entitled to this full share.

Retroactive collection

Here you specify whether you are entitled to income prior to the start date.

If you answer 'YES', you can specify an exact date. If you do not specify a date, the retroactive collection applies to the entire period prior to the start date.

Transfer previously registered works

Only to be filled in if you have selected 'General' as the type of agreement.

Yes: apply the sub-publishing agreement to all works that mention the Original Publisher.

No: only apply the sub-publishing agreement if it is explicitly mentioned in a work declaration.

Apply general sub-publishing agreements

Yes: apply general sub-publishing agreements known to ICE to this agreement.

No: do not apply general sub-publishing agreements known to ICE to this agreement. The sub-publication will thus not be applied automatically to the works.

List of works to which this agreement applies

Only to be filled in if you have selected 'Specific' as the type of agreement. Note that you need to register the works you mention here separately. This form only registers the agreement.
